India formally entered the war on December 3, 1971, leading to Bangladesh's independence on December 16, 1971.

3. Renewed Cooperation (1996-Present):

In recent decades, India and Bangladesh have worked to enhance economic and security collaboration. A landmark agreement in 2015 resolved the long-standing land boundary issue by exchanging enclaves, fostering goodwill. Trade links have grown, with India becoming one of Bangladesh's main trading partners. Strategic cooperation has also improved, particularly in regional connectivity and counterterrorism initiatives. India has invested in Bangladesh's infrastructure, including telecommunications, power, and railroads, contributing to its economic growth.

Sheikh Hasina's Controversial Victory and Political Polarization:

Sheikh Hasina's recent election victory has been surrounded by controversy, leading to increased political polarization in Bangladesh. The Awami League has dominated the political scene for over a decade, but allegations of election manipulation, repression of the opposition, and authoritarian rule have raised concerns about the party's hold on power.

The 2018 and subsequent elections were marred by claims of irregularities, with the opposition, particularly the Bangladesh Nationalist Party (BNP), accusing the ruling party of voter suppression and intimidation. The decline of democratic institutions under Hasina's leadership has been a significant concern, with law enforcement, the judiciary, and the Election Commission often accused of favoring the ruling party. Political tensions have escalated, with street protests, strikes, and violent clashes becoming common, especially during election periods.

The Fall of Sheikh Hasina: A Movement Fueled by Student Protests:

Sheikh Hasina's long reign in Bangladesh has been marked by strong diplomatic ties, infrastructure development, and economic growth. However, growing frustration, particularly among

the youth, has posed a significant challenge to her administration. Student protests, historically influential in shaping Bangladesh's political landscape, have played a crucial role in her potential downfall.

The 2024 elections, widely seen as a sham due to the absence of opposition parties, sparked widespread protests. The youth, disillusioned by years of repression, viewed the elections as another manipulation of democracy. Protests erupted across universities and streets, with the government responding with mass arrests, internet shutdowns, and violent crackdowns. Unlike previous uprisings, these protests gained momentum, drawing in broader sections of society, including civil society and professionals.

The international community, which had largely tolerated Hasina's authoritarian tendencies due to Bangladesh's strategic importance and economic progress, began to express concerns. Sanctions from the United States and European countries further isolated the government. Even India, one of Hasina's closest allies, signaled a shift in its stance, unwilling to be seen as supporting a regime losing public support.

Within the Awami League, internal rifts emerged as younger members distanced themselves from Hasina's conservative policies. Security forces, aligned with the government, hesitated to use excessive force against protesters, fearing a loss of legitimacy. Under mounting domestic and international pressure, Hasina's power gradually eroded, leading to her eventual resignation.

What Were the Bangladeshi Student Protests?

Student protests in Bangladesh have historically played a significant role in shaping the country's political and social landscape. Over the years, students have organized protests against quota reforms in government jobs, government repression, road safety, electoral fraud, and corruption. These protests have often been met with violence, police crackdowns, and internet shutdowns.

A major student movement focused on quota reform in government jobs, which reserved a significant portion of public sector positions for specific groups, such as descendants of liberation fighters. Students argued that the system was unfair and denied equal opportunities to most eligible candidates. Protests in 2018 forced the government to announce reforms, but the movement faced arrests, crackdowns, and accusations of political repression.

Students have also been at the forefront of protests against authoritarianism and electoral fraud, particularly during Sheikh Hasina's controversial election victories. Many young people are disillusioned with the political system, blaming the government for stifling dissent and undermining democracy. Long-standing issues like the Teesta River water dispute could resurface as major points of contention

Security cooperation will also be crucial. Under Hasina, Bangladesh's crackdown on insurgent groups operating in India's northeastern states was highly valued by New Delhi. A change in leadership could lead to a reevaluation of this approach, especially if BNP-affiliated groups distance themselves from India's security concerns. Additionally, China's growing influence in Bangladesh could complicate matters for India. A new government might deepen military and economic ties with Beijing, shifting the regional balance of power and forcing India to work harder to maintain its influence.
